1. All horses must have current Coggings. Out-of-state horses must have valid interstate health certificate papers.
2. All riders must check in at show office, even if pre-registered.
3. Riders under 18 must wear a helmet.
4. Riders must get acknowledged by the time keeper before they start their run.
5. The gate will be closed while pattern is being run by exhibitor.
6. **WESTERN ATTIRE IS REQUIRED FOR ALL RIDERS.**
7. There is a 5-second penalty for knocking over a pole or barrel.
