Rules

1. Must be female
2. Must have had at least one year experience riding horses.
3. Must have not ridden professionally in a rodeo or have won barrels at the CRR.
4. Must have own horse and negative Coggins test.
5. Must fill out entry form & pay fee.
6. All horses must be trained to tie & need breast collar, throat latch, & continuous rein.
7. Each competitor can only enter once and horses cannot be shared.
8. Unnecessary roughness or abuse will not be permitted and will be cause for disqualification and forfeiture of fee.
9. Stallions can only be shown by 18 yr. olds.
10. Western attire is to be worn at all times at the Rodeo events and on the rodeo grounds. Under 18 will be required to ride with a helmet. Contestants must have long sleeve western shirt, long jeans, belt and riding boots with heel.
11. Registration needs to be filled out & \$25.00 entry fee mailed before May 20, 2020.
12. Only 12 spots open. First come first served. All other will be returned.
13. Back tags will be issued. No tag you don't get to ride.
14. You will be eliminated if not in the arena one minute after your name is called.
15. You will be disqualified if your horse's behavior is dangerous to others or yourself.

Note: There are no stalls available for the CRR performances.
